- (a) The following contract clauses are incorporated by reference from the Federal Aviation Agency's Management System (FAAMS) and apply to the extent indicated. The FAAMS clauses are accessible at <a href="http://fast.faa.gov/">http://fast.faa.gov/</a>. (Click on "Toolsets" and then click on "Procurement Toolbox.") In all of the following clauses, "Contractor" and "Offeror" shall mean Seller.
  - (1) 3.2.2.3-8 Audit and Records Negotiation (APR 1996). This clause applies only if this contract exceeds \$1,000,000 and (i) is cost-reimbursement, incentive, time-and-materials, labor-hour, or price-redeterminable type or any combination of these types; (ii) Seller was required to provide cost or pricing data, or (iii) Seller is required to furnish reports as discussed in paragraph (e) of the referenced clause.

In Paragraphs (c)(1), (c)(1)(ii), and (c)(2)(i), "Contracting Officer" shall mean "Contracting Officer or Buyer." In Subparagraph (c)(2)(i)(A), delete "to the Contracting Officer." In Subparagraph (c)(2)(ii)(B), "Government" shall mean "Government or Buyer." In Paragraph (d), "United States" shall mean "United States or Buyer."
  - (3) 3.2.2.3-27 Subcontractor Cost or Pricing Data (APR 1996). This clause applies only if this contract exceeds \$1,000,000. The certificate required by paragraph (b) of the referenced clause shall be modified as follows: delete "to the Contracting Officer or the Contracting Officer's representative" and substitute in lieu thereof "The Boeing Company or any of its wholly owned subsidiaries."
  - (4) 3.2.2.3-30 Termination of Defined Benefit Pension Plans (APR 1996). This clause applies only if this contract exceeds \$1,000,000 and cost or pricing data was required.
  - (5) 3.2.2.3-36 Reversion or Adjustment of Plans for Post-Retirement Benefits Other Than Pensions (APR 1996). This clause only applies if this contract exceeds \$1,000,000 and cost or pricing data was required.
  - (6) 3.2.2.3-37 Notification of Ownership Changes (APR 1996. This clause only applies if this contract exceeds \$1,000,000 and cost or pricing data was required.
  - (7) 3.2.3-5 Administration of Cost Accounting Standards (APR 1996). This clause applies only if clause 3050 or 3051 is incorporated in this contract. Add "Buyer and the" before "Contracting Officer" in paragraph (f).
